- Certified university degree in Public Administration or other relevant subject, at master equivalent or above. (Economics or law also acceptable)
- Prior experience of working with ministries or decentralised governments in Jordan, in specific related to decentralisation issues, is an asset.
- **For International Experts:** A minimum of 5 years (preferably 8 years) in long and short term TA assignments in the field of decentralisation and governance (as general as possible).
- **For Regional Experts:** A minimum of 5 years (preferably minimal 8 years) professional experience in the field of decentralisation and governance within the Jordan public administration or in the region.
- A minimum of 5 years experience in Technical Assistance provision to national governments and/or local governments in the field of decentralisation.
- A minimum of 5 years experience in long term management positions (Team Leader, Component Leader), preferably in international Technical Assistance project.
- For International Experts: A minimum of 3 years professional experience in Jordan is required.
- **For Regional Experts:** A minimum of 10 years professional experience in Jordan/the region is required.
